A Legislative Resolution Titled

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM  
CODY WARE AS THE TERO DIRECTOR**

Legislative Findings:

**WHEREAS**, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

**WHEREAS**, the Crow Nation Government has the inherent sovereign right to promote, regulate and enforce employment laws for the benefit of its members and all employees with tribal jurisdiction; and

**WHEREAS**, the Crow Tribal Government has enacted CLB 09-01, An Act to Establish a Crow Nation Workforce Protection Act, (hereinafter the "Act") which creates the Director of the Crow Tribal Employment Rights Office, in chapter 3, part 1, with specific duties and authorities to implement and enforce the provisions of the Act in 17.3.2.1; and

**WHEREAS**, the Chairman of the Executive Branch submitted Cody Ware as his nominee for the TERO Director on March 23, 2018 for the Legislative Branch confirmation procedure, Rule 31 of the Legislative Branch Rules of Order; and

**WHEREAS**, the Legislature held an Infrastructure Committee meeting on April 10, 2018 to determine whether the nominee submitted by Chairman Not Afraid was qualified and meets the statutory requirements set forth in CLB 09-01. The Legislative Branch Infrastructure Committee held a secret ballot vote with a unanimous concurrence to recommend approval at the next Legislative Branch Session; and

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL  
LEGISLATURE IN SPECIAL SESSION:**

That the following individual Cody Ware is confirmed by the Legislative Branch and shall exercise all authority and duties in accordance with Crow Tribal law and applicable federal law upon entering the oath of office.

**BE IT FURTHER RESOLVED:**

This Legislative Resolution shall take effect immediately upon becoming duly adopted by the Crow Tribal Legislature.
