JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND THE CROW
TRIBAL EXECUTIVE BRANCH ENTITLED:

**“RESOLUTION ADOPTING THE 2019 INDIAN HOUSING PLAN PURSUANT TO CROW
TRIBAL HOUSING ORDINANCE CLB 17-03”**

WHEREAS, the Crow Tribal Executive Branch (hereinafter “Executive Branch”) has the power and responsibility under Article IV, Section 3 of the Crow Tribal Constitution, subject to any limitations imposed upon such powers by the statutes and laws of the United States, to represent the Crow Tribe of Indians in negotiation with Federal, State and local governments and other agencies, corporations, associations, or individuals in matters of welfare, education, recreation, social services and economic development affecting the Crow Tribe; and

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature”) has the power and duty under Article V, Section 2(a) of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, Section 19-10-101 of CLB 17-03, “An Act to Repeal and Replace the Crow Tribal Housing Ordinance” requires the Housing Authority to annually prepare and submit an Indian Housing Plan, as required by NAHASDA, for Indian Housing Block Grant funding from the United States Department of Housing and Urban Development (HUD), including a time period for public comment; and

WHEREAS, the Housing Authority and Housing Board of Commissioners have completed the required public notice and facilitated public meetings in all districts of the Crow Indian Reservation and such public comment was taken into consideration and included in the attached Indian Housing Plan (Exhibit A); and

WHEREAS, Section 19-10-101 of CLB 17-03 further requires a Joint Action Resolution authorizing submission of the Indian Housing Plan to HUD;

**NOW, THEREFORE, BE IT ENACTED BY THE CROW TRIBAL LEGISLATURE AND
THE CROW TRIBAL EXECUTIVE BRANCH:**

Section 1. That the Crow Tribe hereby accepts, approves, and enacts the attached proposed 2019 Indian Housing Plan pursuant to CLB 17-03 "Exhibit A", including all completed, considered, and incorporated public comments, and authorizes its submission to the United States Department of Housing and Urban Development, as required by NAHASDA, for award of Indian Housing Block Grant funding.

Section 2. That, pursuant to CLB 17-03, the budget contained in the 2019 Indian Housing Plan shall be included in the next 2019 Crow Tribal Annual Budget and authorized for expenditure according to, and in compliance with the current fiscal management laws of the Crow Tribe, the Housing Ordinance, this resolution, and all applicable laws and regulations pertaining thereto.


Section 4. The Housing Authority shall ensure timely completion of all required reporting requirements relating to expenditures of the 2019 Indian Housing Plan, including those found in Chapter 11 of CLB 17-03.

Section 4. This Joint Action Resolution shall be effective immediately on the date of approval of this Resolution.


CERTIFICATION






