A Legislative Resolution Titled

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM THE
RENO DISTRICT, WYOLA DISTRICT, AND BIG HORN DISTRICT NOMINATIONS
FOR THE APSAALOOKE NATION HEALTH BOARD**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Legislative Branch established the Apsaalooke Nation Health Board through CLB No. 10-01 (titled "An Act Establishing a Crow Tribal Health Board and Establishing Authority, Duties and Responsibilities of the Apsaalooke Nation Health Board"). As a tribal administrative body representing the Crow Tribe in meeting with the federal government on healthcare matters, to advise the Tribal Government on healthcare budgets, policies, programs and services to the Crow communities. Also, to provide oversight of federal and tribal healthcare programs and services and to carry out other duties assigned by the Executive Branch of the Crow Tribe or tribal law; and

WHEREAS, Chairman Not Afraid submitted a letter with nominations for the Reno District, Latonna Old Elk, Big Horn District, Carol Alden, and Wyola District, Jackie Stewart on June 27, 2018; and

WHEREAS, the Legislature has the lawful authority to confirm Executive Branch nominations for the Apsaalooke Nation Health Board pursuant to CLB 10-01; and

WHEREAS, the Legislative Branch Health and Human Services Committee held a confirmation hearing on July 11, 2018 and the Reno, Wyola and Big Horn nominees received a committee recommendation for approval on the floor at the next Legislative Session.


**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN REGULAR SESSION:**

That the following individuals are hereby legislatively confirmed as members of the Apsaalooke Nation Health Board (Crow Tribal Health Board) and shall exercise all authorities and duties associated with such office pursuant to CLB 10-01 Apsaalooke Nation Health Board:

1. Carol Alden, representing the Big Horn District for a four-year term commencing on May 28, 2018 and ending May 28th, 2022.
2. Jackie Stewart, representing the Wyola District for a four-year term commencing on May 28, 2018 and ending May 28th, 2022.
3. Latonna Old Elk, representing the Reno District for a four-year term commencing on May 28, 2018 and ending May 28th, 2022.
