JOINT ACTION RESOLUTION JAR NO. 19-03

CROW TRIBAL EXECUTIVE BRANCH

A JOINT ACTION RESOLUTION TITLED: “AN ACT APPROVING AND SUPPORTING SUBMISSION OF A FISCAL YEAR 2020 INDIAN HOUSING PLAN & HUD BLOCK GRANT APPLICATION” ON BEHALF OF THE APSAALOOKE NATION HOUSING AUTHORITY, A TRIBALLY DESIGNATED HOUSING ENTITY (TDHE) PURSUANT TO CROW TRIBAL HOUSING ORDINANCE CLB 17-03

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature”) has the power and duty under Article V, Section 2(a) of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Crow Tribal Executive Branch (hereinafter “Executive Branch”) has the power and responsibility under Article IV, Section 3 of the Crow Tribal Constitution, subject to any limitations imposed upon such powers by the statutes and laws of the United States, to represent the Crow Tribe of Indians in negotiation with Federal, State and local governments and other agencies, corporations, associations, or individuals in matters of welfare, education, recreation, social services and economic development affecting the Crow Tribe; and

WHEREAS, pursuant to provisions of section 19-10-101, the Housing Ordinance provides the Apsaalooke Nation Housing Authority (ANHA) the authority prepare an annual Indian Housing Plan (hereinafter IHP) to apply for funding from the United States Department of Housing and Urban Development to support the housing needs of the Apsaalooke people, and the ANHA has prepared a Fiscal Year 2020 IHP and HUD application as a Tribal Organization on behalf of the Tribe; and

WHEREAS, ANHA has identified the needs of the Community after meetings in the Community Districts and consultation with representative of the various districts to maintain and operate housing units on the reservation and included these needs and assessments in the 2020 IHP; and

WHEREAS, the Crow Tribal Executive Branch and Legislature desire to authorize and support the proposed 2020 IHP and HUD Block Grant application as attached hereto and herein incorporated by reference as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL EXECUTIVE AND LEGISLATIVE BRANCHES AS FOLLOWS:

Section 1. The Crow Tribe hereby authorizes, approves and supports the Board of Commissioners of the Apsaalooke Nation Housing Authority to submit the attached Fiscal Year 2020 IHP HUD Block Grant Application on behalf of the Crow Tribe as set forth in Exhibit A.

Section 2. If the application is funded, the expenditure of funds thereunder by the Apsaalooke Nation Housing Authority are specifically authorized as an addendum to the Crow Tribal fiscal year 2020 budget, in an amount identified in the grant award and grant documents, as finally awarded.

Section 3. Effective Date. This Joint Action Resolution shall take effect upon its enactment by the Crow Tribal Legislature in accordance with the 2001 Crow Tribal Constitution.




