A Legislative Resolution Titled:

**A RESOLUTION APPROVING SUBMISSION OF A FISCAL YEAR 2020
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) APPLICATION ON
BEHALF OF THE APSAALOOKE NATION HOUSING AUTHORITY A TRIBALLY
DESIGNATED HOUSING ENTITY (TDHE) PURSUANT TO CROW TRIBAL
HOUSING ORDINANCE CLB 17-03**

Legislative Findings:

WHEREAS, the Crow Tribal Executive Branch (hereinafter “Legislature”) has the power and duty under Article V, Section 2(a) of the Crow Tribal Constitution to promulgate and adopt laws, governance of the Crow Tribe; and

WHEREAS, the Crow Tribe Executive Branch (hereinafter “Executive Branch”) has the power and responsibility under Article IV, Section 3 of the Crow Tribal Constitution, subject to any limitations imposed upon such powers by the statutes and laws of the United States, to other agencies, corporations, associations, or individuals in matters of welfare, education, recreation, social services and economic development affecting the Crow Tribe; and

WHEREAS, the Executive Branch has the general duty under Article IV, Section 4 of the Crow Tribe Constitution to implement all laws, resolutions and policies duly adopted by Legislature; and

WHEREAS, the Crow Tribe enacted “An act to Repeal and Replace the Crow Tribal Housing Ordinance” CLB 17-03, Section 19-10-102 Other Outside Source Funding Authorized.

WHEREAS, the Legislature has granted the Apsaalooke Nation Housing Authority (ANHA) the authority to apply for Calendar Year 2020 Community Development Block Grants (CDBG) as a Tribal Designated Housing Entity on behalf of the Tribe; and

WHEREAS, ANHA has accepted this authority and is applying for CDBG grants for the purpose of infrastructure repair and development to affect ANHA low rent areas; and

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN QUARTERLY SESSION:**


Section 1. The Board of Commissioners of the Apsaalooke Nation Housing Authority approves submission of Community Development Block Grant Applications (CDBG) on behalf of the Crow Tribe.

Section 2. Effective Date. This Legislative Resolution shall take effect upon its enactment by the Crow Tribal Legislature in accordance with the 2001 Crow Tribal Constitution.

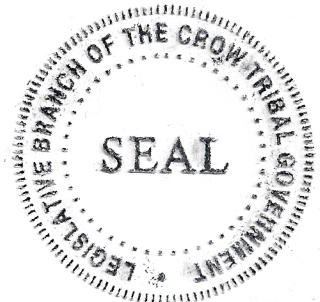


