A Legislative Resolution Titled:

A RESOLUTION OF THE CROW TRIBAL LEGISLATURE SUPPORTING THE TRIBAL ENGAGEMENT OF THE ACQUISITION OF THE BIG SKY CONVENTION CASINO PROJECT LAND OFF RESERVATION

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Tribal Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, Legislative Resolution 10-20, Section 1. Branch Policy Regarding Legislative Resolutions states, "[t]he policy of the Legislature shall be that legislative resolutions are an expression of the voice of the elected Senators of the Crow Legislature, and which is based on inherent sovereign tribal authority of the Crow Tribal General Counsel, as delegated to the Legislature under the 2001 Constitution and which shall be categorized as follows: (5) Recommendation Resolutions. Resolutions for making recommendations, statements of support, or endorsements of any public election, the hiring of any public official, or the establishment of governmental policy by law or otherwise, including federal and state legislation, which may affect the Crow Tribe and its members."; and

WHEREAS, The Crow Tribal Legislature has been made aware that a certain opportunity has become available to acquire commercial property and business off-reservation, envisioned as the "Big Sky Convention Casino Project", to which the Executive Branch has also agreed that this potential venture would be worth entering into an official engagement with certain business partners to evaluate such possibility; and

WHEREAS, The Crow Tribal Legislature desires to enter into an engagement with certain commercial and business opportunities for the Crow Tribe,

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN REGULAR SESSION:

Section 1. Pursuant to LR 10-20 and the powers vested in the Legislature to issue supporting action of the Legislature, the Legislature hereby fully supports tribal action pursuant to the 2001 Constitution to engage the business venture to acquire commercial property and business off-reservation, envisioned as the "Big Sky Convention Casino Project".

Section 2. That the Crow Tribal Legislature, through this supportive resolution hereby requests that the engagement documents required for review including but not limited to: any action requiring a limited waiver of sovereign immunity, collateral security or any other document requiring approval by the Crow Tribal Legislature under the 2001 Constitution, to be submitted by the Executive Branch as soon as possible for consideration by the Crow Tribal Legislature.

Section 3. This Resolution shall take effect immediately upon becoming duly adopted by the Legislature.
