A Legislative Resolution titled:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM THE
MIGHTY FEW DISTRICT NOMINATION TO THE BOARD OF COMMISSIONERS
FOR THE APSAALOOKE NATION HOUSING AUTHORITY**

Legislative Findings:

WHEREAS, Article V, Section 2(a) of the Crow Tribal Constitution vests the Crow Tribal Legislature (hereinafter “Legislature”) with the power and duty to promulgate and adopt resolutions in accordance with the Crow Tribal Constitution and federal law for the governance of the Crow Tribe; and

WHEREAS, Legislative Resolution 10-20 “A Resolution of the Crow Tribal Legislature to Establish Branch Policy and Procedure for Legislative Resolutions” provides authority for enacting “[r]esolutions providing for the confirmation of tribal officers . . . in accordance with established tribal law and legislative procedure; and

WHEREAS, Crow Legislative Bill 17-03 “An Act to Repeal and Replace the Crow Tribal Housing Ordinance” 19-2-105 provides, “Housing Commissioners shall be appointed by the District Senators of the Legislature, through majority decision as expressed in writing to the Speaker of the House. All appointments shall be subject to confirmation by the Legislature”; and

WHEREAS, on April 28, 2020 the following nomination was made for by the Mighty Few District Senators’ consensus as documented to the Speaker of the House:

1. Lesley Jackson Kaboutie for the Mighty Few District,

WHEREAS, on April 28, 2020, the Infrastructure Committee held a confirmation hearing on record pursuant to Rule 31 “Legislative Confirmation Procedure” and made a recommendation for the nominee by a secret ballot vote which resulted in unanimous official recommendation for confirmation by the full Legislature; and

WHEREAS, the full Legislature on April 29, 2020 voted to confirm the Mighty Few District nomination to the Board of Commissioners for the Apsaalooke Nation Housing Authority.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN SPECIAL SESSION:**


Section 1. Confirmation of Board of Commissioners. The following individual is hereby confirmed as the Mighty Few District Board of Commissioners for the Apsaalooke Nation Housing Authority and shall exercise all duties and authorities in accordance with Crow Tribal law and applicable federal law upon entering the oath of office.

1. Lesley Jackson Kabotie for the Mighty Few District

Section 2. Effective Date. This Resolution shall take effect immediately upon its passage by the Full Legislature.
