A Legislative Resolution Titled:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE REPEALING LR 14-15
AND ESTABLISHING THE POSITION OF LEGISLATIVE BRANCH CHIEF OF
STAFF**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter “Legislature”) has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt resolutions in accordance with the Tribal Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Legislature has experienced a need resulting in the restructuring of staff serving the Senators of the Crow tribal Legislature, which has now resulted in restructuring and rebuilding much of the legislative framework; and

WHEREAS, the Legislature has determined that its specific needs tailored to ensuring Legislation is administered according to the Rules of Order and to ensure that all public information regarding such Legislation is properly disseminated; and

WHEREAS, Sheri Chandler, current Public Relations Officer has returned from furlough status and has carried the duties of administrative officer since such return without proper authorization; and

WHEREAS, based upon the need to restructure the personnel framework and to ensure Branch legislation is properly administered, it is necessary and proper to combine the vacant position of Administrative Officer with the current Public Relations Officer as established by LR 14-15;

**NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN
SPECIAL SESSION:**

Section 1: The position “Public Relations Officer” established by LR 14-15 is hereby repealed; and, the position of “Legislative Branch Administrative Officer” is hereby eliminated, and such duties of both former positions are now combined, establishing the position of Legislative Branch Chief of Staff.

Section 2: The Legislative Branch Chief of Staff shall continue to be full-time, permanent staff member. The duties and qualifications of the Legislative Branch Chief of Staff


shall be as provided in the attached Position Description, and the Legislative Branch Personnel Practices and Policy Manual, as updated and amended, shall fully govern the position.

Section 3. Sheri Chandler, current Public Relations Officer, shall assume this newly created position as soon as practical. The Speaker of the House shall be authorized to make any such budget modification as may be required to implement the new Legislative Chief of Staff duties to Ms. Chandler's current position.

Section 4. This Resolution shall take effect immediately upon becoming duly adopted by the Legislature.


CERTIFICATION


