NOTICE 2020 CROW TRIBE EXECUTIVE BRANCH ELECTIONS

FILING DEADLINE FOR CANDIDATES FOR

CHAIRMAN, VICE-CHAIRMAN, SECRETARY & VICE-SECRETARY

In accordance with the Constitution and By-Laws of the Crow Nation, and the Amended Comprehensive Election Ordinance, notice is hereby given that all candidates for the Chairman, Vice-Chairman, Secretary & Vice-Secretary of the Executive Branch must file for candidacy by 5:00 p.m. on Tuesday, September 1st, 2020.

The **Primary Election** of the Executive Branch will be held at the Apsaalooke Center (Multi-Purpose Building), Crow Agency, MT. on **Saturday, October 10th, 2020**. Voting will be by secret ballot. A **General Election** shall be conducted on **Saturday, November 7th, 2020**. The two (2) candidates receiving the highest number of votes in the Primary Election shall be placed on the General Election Ballot. The voting polls will open from 9:00 a.m. and will close at 8:00 p.m.

Qualifications for persons interested in filing for candidacy are:

- Must be and enrolled member of the Crow Nation;
- Must be 30 years of age or older;
- Must physically reside within the exterior boundaries of the Crow Reservation for at least one (1) year **prior** to being a candidate. (Must duly provide proof of residence);
- Must have High School Diploma or General Equivalency Degree unless over the age of fifty-five (55) years;
- Must have no felony convictions; and
- Must resign from employment by the Crow Tribe, the United States Government, or the State of Montana or any subdivision thereof prior to taking the Oath of office.

Interested persons may obtain a Declaration of Candidacy Affidavit from the Office of Mr. R. Knute Old Crow, Sr., Crow Tribal Secretary. Candidates must submit the filing Affidavit with a **non-refundable Five Hundred dollar (\$500.00) filing fee (money order)**. A full background check and verification of candidate qualifications will be conducted on all candidates. The affidavit and fee must both be completed and received in the Tribal Secretary's office by **5:00 p.m. Tuesday, September 1st, 2020**.
