**NOTICE APSAALOOKE NATION
ABSENTEE VOTING
2020 CROW TRIBE EXECUTIVE BRANCH ELECTION**

Pursuant to the Crow Tribal Election Ordinance as amended in the April 2016 Session of the Legislature by CLB No. 16-01 “AN ACT TO AMEND THE CROW TRIBAL ELECTION ORDINANCE TO PROVIDE FOR ABSENTEE VOTING IN ALL FUTURE TRIBAL ELECTIONS,” any Crow Tribal member may vote by Absentee Ballot in the 2020 Executive Branch Primary and General Elections.

Requests to vote by Absentee Ballot must be made either in person at the Crow Tribal Secretary’s office, or by mailing a request form to the Secretary’s office. In order to request Absentee Ballots, voters must sign a form agreeing that they will only be able to vote by Absentee Ballot and shall not have the right to vote by traditional means at the polling place on Election Day.

If you decide to request voting by Absentee Ballot:

- 1) You may only vote by Absentee Ballot in both the Primary and General Election.
- 2) Upon signing the request form, you will receive blank Absentee Ballots and return envelope for Elections.
- 3) You may only vote for Candidates that have been certified to be qualified to be on the Ballot for the applicable Election. Non-certified write-in candidates are not allowed such votes will not be counted.
- 4) Your Absentee Ballots must be received by the Secretary’s office by the applicable Election Day at the Special Post Office Box for Absentee Ballots.

Request for Absentee Voting may be made beginning **Monday, July 13th, 2020**. The deadline for making in-person request is **Friday, October 2nd, 2020**. The deadline for requesting by U.S. Mail is **Thursday, September 10th, 2020**, and your signed and notarized form must be received by that date.
