A Legislative Resolution Titled:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM
THE RENO DISTRICT, AND THE LODGE GRASS DISTRICT, CONFIRMATION
FOR THE BOARD OF COMMISSIONERS OF THE APSAALOOKE NATION
HOUSING AUTHORITY**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Legislative Branch established the Board of Commissioners of the Apsaalooke Nation Housing Authority through CLB No. 17-03 (titled "An Act to Repeal and Replace Establishing the Crow Tribal Housing Ordinance and Establishing Authority, Duties and Responsibilities of the Board of Commissioners of the Apsaalooke Nation Housing Authority (9-2-105)). As a tribal administrative body representing the Crow Tribe in meeting with the federal government on housing matters, to advise the Tribal Government on housing budgets, policies, programs and services to the Crow communities. Also, to provide oversight of federal and tribal housing programs and services and to carry out other duties assigned by the Executive Branch of the Crow Tribe or tribal law; and

WHEREAS, Legislative Resolution 10-20, hereinafter "LR 10-20" states, the policy of the Legislature shall be that legislative resolutions are an expression of the voice of the elected Senators of the Crow Tribal Legislature, and which is based on the inherent sovereign tribal authority of the Crow Tribal General Council, as delegated to the Legislature under the 2001 Constitution; and

WHEREAS, Legislative Resolutions are utilized for confirmations of tribal officers or judges, in accordance with established and legislative procedure; and

WHEREAS, the Legislature has the lawful authority to confirm Executive Branch nominations for the Board of Commissioners of the Apsaalooke Nation Housing Authority pursuant to CLB 17-03; and

WHEREAS, the Legislative Branch Infrastructure Committee held a confirmation hearing on September 8, 2020 and the Reno, and Lodge Grass nominees received a committee recommendation for approval on the floor at the next Legislative Session.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN REGULAR SESSION:


Section 1. Confirmation of Board of Commissioners and Reporting. That the following individuals are hereby legislatively confirmed as members of the Board of Commissioners of the Apsaalooke Nation Housing Authority (Crow Tribal Housing Commission) and shall exercise all authorities and duties associated with such office pursuant to CLB 17-03 Board of Commissioners of the Apsaalooke Nation Housing Authority:

1. Jeff Packs the Hat, representing the Lodge Grass District for a four-year term commencing on October 6th, 2020 and ending October 6th, 2024.
2. Dr. Lanny Real Bird, representing the Reno District for a four-year term commencing on October 6th, 2020 and ending October 6th, 2024.

Section 2. Effective Date. This Resolution shall take effect immediately upon its passage by the full legislature.


