A Legislative Resolution Titled:

A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO REQUEST MONTANA DEPARTMENT OF TRANSPORTATION TO COMPLETE A SPEED SURVEY FOR THE WYOLA DISTRICT AND THE LODGE GRASS DISTRICT AS WELL AS RESERVATION WIDE

Legislative Findings:

WHEREAS, the Crow Tribal Legislature ("Legislature") has the power and duty under Article V, Section 2(a) 2001 Crow Constitution to promulgate and adopt resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe of Indians; and

WHEREAS, LR 10-20, section (1), states, Legislative Resolutions for final approval of an Executive Branch proposal or for the authorization of tribal action in accordance with the 2001 Crow Constitution and other applicable tribal law or federal law; and

WHEREAS, the Crow Tribe is empowered to, under the Crow Constitution to promote and protect the health, peace, morals, education, and general welfare of the Crow Nation, the communities and its people; and

WHEREAS, the Montana Department of Transportation ("MDT") has the jurisdiction to investigate and initiate a speed study; and

WHEREAS the Legislature is requesting MDT to implement a lower speed limit and cautionary lights for the Wyola District, and Lodge Grass District; and

WHEREAS, Montana highway, I-90 Frontage Road East has been known for deadly wrecks and causes of deaths on the Crow Reservation; and

WHEREAS, the Legislative Branch is requesting Big Horn County to set all county roads at the speed limit of 35 mph; and

WHEREAS, the Legislative Branch is requesting the department of transportation or an engineer to conduct an engineering and traffic investigation based on the belief that a speed limit on a highway set by (MCA 61-8-303 or MCA 61-8-312) is greater or less than is reasonable or safe establish and implement prevention and intervention programs for the people of the Crow Tribe; and

WHEREAS, this Resolution will serve as record of support from the Crow Tribal Government for the Traffic Investigation and Speed Study within the exterior boundaries of the Crow reservation; and

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN REGULAR SESSION:

- 1. The Legislative Branch fully supports a Traffic Investigation Crow for the entire Crow reservation.
- 2. That the Crow Tribal Legislature hereby authorizes and fully supports speed limit investigation.

BE IT FINALLY RESOLVED:

This Legislative Resolution shall take effect immediately upon being duly adopted by the Legislature.
