A Legislative Resolution Titled

“A RESOLUTION OF THE CROW TRIBAL LEGISLATURE APPOINTING JACKIE BLACKSMITH AS THE CHIEF OF STAFF”

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Legislature has determined a need to restructure the staffing serving the Senators of the Crow Tribal Legislature, which has resulted in restricting and rebuilding the legislative personnel framework; and

WHEREAS, the Legislature has determined to ensure that all public information regarding Legislation is properly disseminated and the processes within the Rules of Order are administered correctly with the Legislative Branch Office; and

WHEREAS, the Legislature has experienced a need to restructure staff, and the position has become vacant, Jackie Blacksmith has returned from furlough and will assume the vacant position of Chief of Staff (LR 20-09); and

WHEREAS, the Legislative Branch shall advertise the newly vacated position of Branch Administrative Assistant; and


NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN SPECIAL SESSION:

Section 1. The Legislative Branch Chief of Staff position and duties shall be assumed by Jackie Blacksmith. The Speaker of the House shall be authorized to make any such budget modifications to implement the current position of Chief of Staff.

Section 2. This Resolution shall take effect immediately upon becoming adopted by the Legislature.
