A Legislative Resolution Titled

**“A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO APPOINT ONE
TEMPORARY ALTERNATE ELECTION JUDGE PER DISTRICT FOR THE
ELECTION YEAR 2020 IN RESPONSE TO COVID-19 PANDEMIC”**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, The Legislature has the authority pursuant to CLB 04-05 “An Act to Adopt an Amended Election Ordinance for Election of Crow Tribal Executive Branch Officials and Members of the Crow Tribal Legislature, For Recall and Referendum Elections and for Elections to Amend the Tribal Constitution” to appoint District Election Judges; and

WHEREAS, Crow Tribal Government has issued a Declaration of State of Emergency Related to the Disease COVID-19 Novel Coronavirus (JAR 20-01), because of the health and safety concerns of seated election judges, they have been excused from serving during the 2020 Election year for Executive Branch Elections; and

WHEREAS, the Crow Tribal Secretary during the October Session 2020, has requested additional appointments for election judges to serve temporarily for the 2020 Election Year; and

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN SPECIAL SESSION:**

Section 1. The Legislative Branch district delegation shall select a temporary alternate from their respective districts to serve as the district’s temporary alternate Election Judge for the 2020 Election Year as follows:


1. Big Horn District temporary appointment as alternate Election Judge, Whittni Shea White
2. Reno District temporary appointment as alternate Election Judge, Rhonda Jefferson
3. Pryor District temporary appointment as alternate Election Judge, Bethany Sees the Ground

4. Lodge Grass District temporary appointment as alternate Election Judge Cyle BlackEagle
5. Wyola District temporary appointment as alternate Election Judge, Shania WhiteClay
6. Black Lodge District temporary appointment as alternate Election Judge, Scotty Dawes

Section 2. This Resolution shall take effect immediately upon becoming adopted the Crow Tribal Legislature.
