A Legislative Resolution Titled

**“A RESOLUTION OF THE CROW TRIBAL LEGISLATURE OF SUPPORT FOR THE
APSAALOOKE HEALTH EQUITY PROJECT TO DO A COMMUNITY HEALTH
ASSESSMENT (CHA) WITHIN THE EXTERIOR BOUNDARIES OF THE CROW
INDIAN RESERVATION”**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Legislature fully supports the Apsaalooke Health Equity Project to provide assessments for Crow Tribal members for assistance and aid; and

WHEREAS, the Community Health Assessment (hereinafter “CHA”) will help identify needs and resources for a good life from our people in each district and the reservation as a whole; and

WHEREAS, data collected will be owned by the Crow people once completed; and

WHEREAS, data collected can also be utilized to write grants and to show unmet needs of the people; and

WHEREAS, the data collected will also help Crow Tribal Government leaders to be informed and make decisions on how to best serve our communities and nation


**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL
LEGISLATURE IN REGULAR SESSION:**

THAT, the Crow Legislative Branch hereby finds and declares its support for the Apsaalooke Equity Project for Community Health Assessment.

FURTHER, this Resolution of Support shall take effect immediately upon passage by the Crow Tribal Legislature.


CERTIFICATION
