A LEGISLATIVE RESOLUTION TITLED:

**A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO REMOVE RENO
DISTRICT REPRESENTATIVE YVON LITTLE LIGHT-MEDICINE TAIL, JR. AS
CHAIRMAN OF THE ECONOMIC DEVELOPMENT COMMITTEE.**

WHEREAS the Crow Tribal Legislature (the “Legislature”) has the power and duty under Article V, Section 2 of the Crow Tribal Constitution and Bylaws to promulgate and adopt laws, resolutions, and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS Section 1(8) of LR 10-20 (Establishing Branch Policy and Procedure for Legislative Resolutions), provides for a specific category of Legislative Resolutions for legislative reprimand, contempt of the Legislature, and/or other disciplinary action; and

WHEREAS LR 16-14 (Ratifying Legislative Branch Uniform Committee Bylaws) sets forth the duties and authorities and procedures governing legislative branch committees and elected officers of the same; and

WHEREAS under Articles III & IV of LR 16-14, Chairmen of the legislative committees have the duty to call and conduct meetings no less than once per month; and

WHEREAS members of the Crow Tribal Legislature take an oath upon entering office to serve the Crow Tribe of Indians and the Apsaalooke People with the utmost diligence and to faithfully discharge the duties of an elected tribal legislator; and

WHEREAS Sen. Yvon Little Light-Medicine Tail, Jr. was elected to serve as the Chairman of the Legislative Economic Development Committee in January of 2022; and

WHEREAS Sen. Yvon Little Light-Medicine Tail, Jr., has failed to meet his duty to schedule and conduct committee meetings, as required under LR 16-14, and only scheduled two (2) Economic Development Committee meeting over the past ten (10) months.

1. That Reno District Representative, Sen. Yvon Little Light-Medicine Tail, Jr., be immediately removed from his position as Chairman of the Economic Development Committee of the Legislature.
2. That, commensurate with this removal, compensation for Reno District Representative, Sen. Yvon Little Light-Medicine Tail, Jr., shall return to the base pay rate, effective on the date of this Resolution's enactment.


