### LEGISLATIVE RESOLUTION NO. LR 23-05

Introduced by the Infrastructure Committee

#### A LEGISLATIVE RESOLUTION TITLED:

A RESOLUTION OF THE CROW TRIBAL LEGISLATURE TO CONFIRM THE MIGHTY FEW AND BLACK LODGE DISTRICTS APPOINTMENTS TO THE BOARD OF COMMISSIONERS FOR THE APSAALOOKE NATION HOUSING AUTHORITY.

WHEREAS the Crow Tribal Legislature (the "Legislature") has the power and duty under Article V, Section 2 of the Crow Tribal Constitution and Bylaws to promulgate and adopt laws, resolutions, and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS under the Crow Tribal Housing Ordinance, enacted under CLB 17-02 and codified at Title 19 of the Crow Law and Order Code (CLOC), the Crow Tribal Housing Authority is governed by a Board of Commissioners consisting of six (6) members, one from each district, who serve staggered four (4) year terms, without limitation as to the number of terms; and

WHEREAS CLOC § 19-2-105 provides that "Housing Commissioners shall be appointed by the District Senators of the Legislature, through majority decision as expressed in writing to the Speaker of the House," subject to confirmation by the Legislature; and

WHEREAS on July 18, 2023, the Speaker of the House received written notice that the following individuals were being re-appointed by unanimous consensus of their respective District Representatives:

- 1. Leslie Kabotie, Mighty Few District; and
- 2. Melvin Ware, Black Lodge District; and

WHEREAS the Infrastructure Committee of the Legislature met on July 19, 2023, held hearings on these appointments, and voted unanimously to recommend that the appointments be confirmed by the full body of the Legislature during the July 2023 Quarterly Session.

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN REGULAR SESSION:

- 1. That the following individuals are hereby confirmed by the Crow Tribal Legislature to serve as members of the Board of Commissioners for the Apsaalooke Nation Housing Authority and shall exercise all duties and authorities in accordance with Crow Tribal law and applicable federal law upon entering the oath of office.:
  - a. **Leslie Kabotie**, representing the Mighty Few District for another four (4) year term, commencing on July 19, 2023, and ending on July 19, 2027.
  - b. **Melvin Ware**, representing the Black Lodge District for another four (4) year term, commencing on July 19, 2023, and ending on July 19, 2027.
- 2. That this Resolution shall take effect immediately upon its enactment by the Legislature.
