JOINT ACTION RESOLUTION OF THE CROW TRIBAL EXECUTIVE BRANCH AND THE CROW TRIBAL LEGISLATIVE BRANCH TITLED:

"A JOINT ACTION RESOLUTION AUTHORIZING AND APPROVING A LOAN BETWEEN THE APSAALOOKE NATION HOUSING AUTHORITY AND MERCY COMMUNITY CAPITAL TO ENABLE THE COMPLETION OF A LOW-INCOME **HOUSING TAX CREDIT PROJECT"**

Legislative Findings:

WHEREAS, the Crow Tribal Legislature (hereinafter "Legislature") has the power and duty under Article V, Section 2(a) of the Crow Tribal Constitution to promulgate and adopt laws, resolutions and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS, the Crow Tribal Executive Branch (hereinafter "Executive Branch") has the power and responsibility under Article IV, Section 3 of the Crow Tribal Constitution, subject to any limitations imposed upon such powers by the statutes and laws of the United States, to represent the Crow Tribe of Indians in negotiation with Federal, State and local governments and other agencies, corporations, associations, or individuals in matters of welfare, education, recreation, social services and economic development affecting the Crow Tribe; and

WHEREAS, the Executive Branch has the general duty under Article IV, Section 4 of the Crow Tribal Constitution to implement all laws, resolutions and policies duly adopted by Legislature; and

WHEREAS, the Executive Branch and Legislature have heretofore approved the contracts developing a Low-Income Housing Tax Credit project to rehabilitate 31 housing units, and

WHEREAS, the Apsaalooke Nation Housing Authority (ANHA) has been overseeing this project, and is in need of a short-term loan to finance the cash flow requirements of the balance of the project, with such loan to be repaid out of project funds, that will be made available, as the project is completed, and

WHEREAS, the attached contract documents between the ANHA and Mercy Community Capital, of Denver, Colorado have been negotiated to facilitate this loan and its repayment out of project funds, and are needed immediately to timely meet project deadlines, with approval thereof of the utmost urgency, in this context, and

WHEREAS, the attached documents provide for a limited waiver of sovereign immunity, similar to other limited waivers of sovereign immunity approved by the Legislature in order for business activities to be conducted with entities of the Apsaalooke Nation in similar circumstances,

NOW, THEREFORE, BE IT ENACTED BY THE CROW TRIBAL EXECUTIVE AND LEGISLATIVE BRANCHES; BY THE CROW TRIBAL LEGISLATURE IN SPECIAL SESSION:

Section 1. The Board of Commissioners of the Apsaalooke Nation Housing Authority is approved to enter and complete the attached Loan and documents supporting this loan as set forth in Exhibit A, with amendments, as necessary; and

Section 2. The Board of Commissioners of the Apsaalooke Nation Housing Authority is approved and authorized to execute the limited waiver of sovereign immunity found in these documents, to the limited extend found therein; and

Section 2. Effective Date. This Joint Action Resolution shall take effect upon its enactment by the Crow Tribal Legislature in accordance with the 2001 Crow Tribal Constitution.
