LEGISLATIVE RESOLUTION NO. LR 23-09

Introduced by the Health and Human Services Committee

A LEGISLATIVE RESOLUTION TITLED:

**A RESOLUTION APPROVING AND ADOPTING AN UPDATED
ORGANIZATIONAL CHART FOR THE CROW TRIBE LEGISLATIVE BRANCH.**

WHEREAS the Crow Tribal Legislature (the “Legislature”) has the power and duty under Article V, Section 2 of the Crow Tribal Constitution and Bylaws to promulgate and adopt laws, resolutions, and guidelines in accordance with the Constitution and federal laws for the governance of the Crow Tribe; and

WHEREAS in accordance with Article V, Section 1 of the Crow Tribal Constitution the Legislature shall operate as a separate and distinct branch of the Crow Tribal Government and shall exercise a separation of powers from the other branches of tribal government; and

WHEREAS the Health and Human Services Committee has been charged with overseeing, deliberating, and making recommendations on certain personnel matters for the Legislature, for final approval by the full body of the Legislature; and

WHEREAS the Health and Human Services Committee has been working on updates to the Legislature’s organizational chart, position descriptions, job duties, and related personnel matters since September of 2022; and


WHEREAS on November 14, 2023, the Health and Human Services Committee unanimously voted to approve and recommend the full body of the Legislature adopt the updated organizational chart and position titles for the staff of the Crow Tribe Legislative Branch, attached hereto, and incorporated by reference.

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE IN SPECIAL SESSION, THAT:

1. The Crow Tribe Legislative Branch hereby approves and adopts the attached updated organizational chart and position titles listed therein.
2. All previously enacted Legislative Resolutions inconsistent with this LR 23-09, are hereby repealed and rescinded to the extent of such inconsistency. This shall not apply to any language in said Resolution, that is consistent or unrelated to this LR 23-09.
3. That this Legislative Resolution shall take effect immediately upon its enactment.


CERTIFICATION

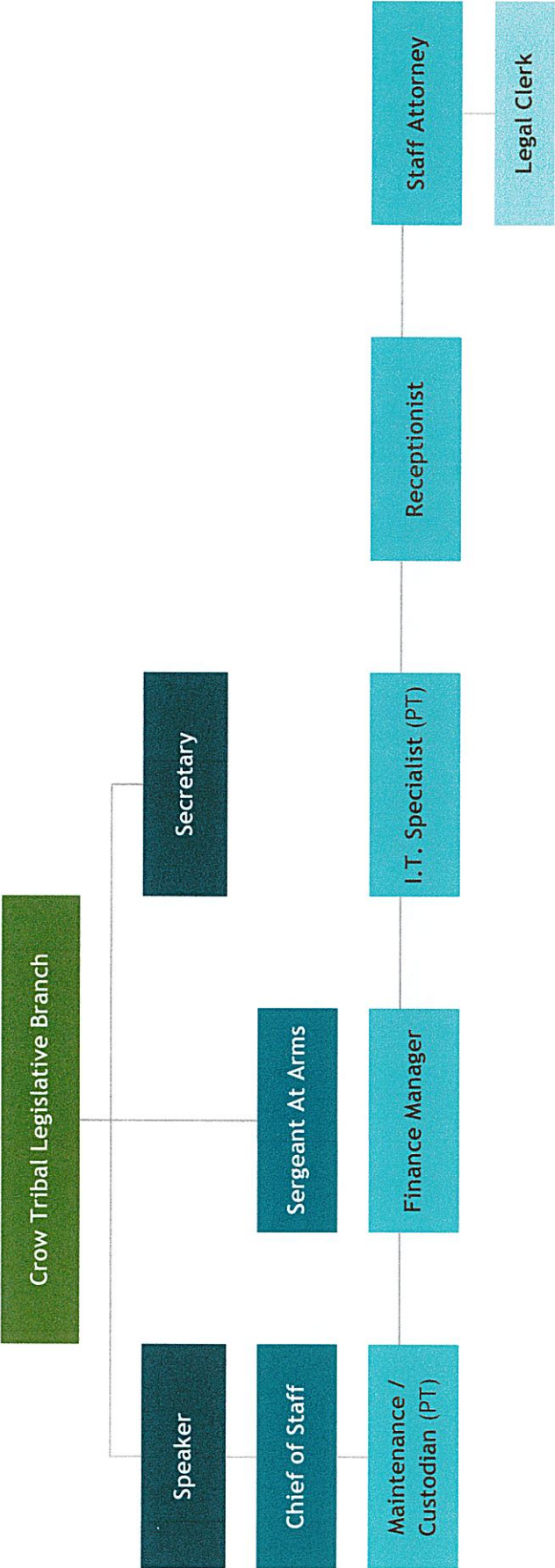


