Notice of Public Hearings

Pursuant to Rule 20¹ of the Legislative Branch Rules of Order, notice is hereby made to the Crow Tribal General Council of public hearings held in each of the six districts of the Crow Indian Reservation for the purpose of receiving written and verbal testimony from the tribal membership about the following proposed legislation, submitted by the Executive Branch:

1. A Joint Action Resolution entitled: "Final Approval of the Certificates of Organization and Articles of Operation of Medicine Rock Holdings, LLC, Arrowhead Mountain Services, LLC, and Lost Creek Lending, LLC."

<u>Summary</u>: This proposed J.A.R. would establish a wholly owned tribal LLC as a holding company (Medicine Rock Holdings, LLC) and two subsidiaries owned and managed by that holding company (Arrowhead Mountain Services, LLC and Lost Creek Lending, LLC). Lost Creek Lending, LLC would then engage in the business of providing short-term consumer loans online to individuals residing in other states, while Arrowhead Mountain Services, LLC would engage in the business of servicing these loans for Lost Creek Lending, LLC.

2. A Crow Legislative Bill entitled: "Amending the Crow Law and Order Code to Include the Crow/Apsaalooke Online Lending Act."

<u>Summary</u>: This proposed CLB is intended to provide the laws, rules, and regulations under which these online lending and related services would operate, and to establish a regulatory framework and authority responsible for licensing and ensuring compliance with the law.

¹ "Rule 20: *Deferral for Public Hearing* Any proposed Legislative Resolution, Joint Action Resolution, or Bill may be deferred for public hearing before final vote by the Legislature, if the proposal is deemed to be of critical public importance. Such deferral shall provide an opportunity for the Crow Tribal membership to offer testimony and opinions regarding the proposal."
